I can confirm on behalf of Great Yarmouth and Waveney, North Norfolk, South Norfolk, Norwich and West Norfolk CCGs and in accordance with S.1 (1) of the Freedom of Information Act 2000 (FOIA) that we do hold the information that you have requested. *The proposed tariff will be fixed, with an uplift of 2.5% for inflation but an expectation of efficiency savings of 5% for the three-year contract duration.*
